Dr. Greg Davis, a consultant from Ohio State who has coordinated the project, said, "Making the most of this kind of survey requires committed leadership. The leadership provided by the Mayor and the Economic Development Department in the most recent survey was, by far, one of the key components of this program's success."

The focus groups will be conducted in early summer at the Chamber office. Three different groups are being invited to participate: Retail business owners, Professional business owners, and Service business owners. Each session will last about 90 minutes and will consist of a series of questions and responses that will be used to provide additional data that will help us maintain our reputation as a community that supports a positive business climate. Dr. Davis will conduct the sessions.

ECONOMIC STIMULUS ACT: SMALL BUSINESS WRITE-OFFS

Our thanks go to Gregg Finkler, treasurer of the Strongsville Chamber, for providing the following information as a service to our members:

The new economic stimulus law, signed on February 13, officially called the Economic Stimulus Act of 2008, provides one time tax rebates to individuals under certain income levels. BUT THE BEST TAX BREAKS IN THE LAW ARE RESERVED FOR SMALL BUSINESS OWNERS! Specifically, the new law contains these two key tax breaks:

1. Section 179 Expensing—under this section of the tax code, you can currently deduct, or "expense", the cost of business assets placed in service during the year, up to a specified maximum. Based on prior law, the annual limit was \$125,000, although the inflation-adjusted amount for 2008 was \$128,000. Section 179 deductions are phased out to the extent that they exceed a threshold of \$500,000 (\$510,000 for 2008).

The new law doubles the maximum annual deduction to \$250,000. It also jumps the phase-out threshold all the way up to \$800,000. But these enhancements apply only for assets placed in service in 2008. For 2009 and 2010, the figures revert to the previous levels.

Warning: If you have a fiscal year business, the increased Section 179 deduction and phase-out threshold do not take effect until the fiscal year begins in 2008. You will want to "time" purchases accordingly.

2. Bonus Depreciation – The new law enables you to write off 50% of the cost of qualified business assets placed in service in 2008. Note that this tax break only applies to new assets. It can't be claimed for used equipment. One exception: Assets sold by a taxpayer, and then leased back, may qualify.

As with Section 179 Expensing, the cut-off date for placing assets in service is generally December 31, 2008. But this deadline is extended to December 31, 2009 for qualifying property with a cost recovery period of 10 years or longer, certain transportation, and aircraft.

Best of all, you can claim bonus depreciation for the same assets that qualify for Section 179 deductions. The remaining balance, if any, is available for regular depreciation deductions.
